## REPORT ON USE OF GENERAL REVENUE DEDICATED ACCOUNTS 82nd LEGISLATURE, 2011

This report lists the General Revenue Dedicated accounts and balances that are used for budget certification purposes according to Section 403.095, Government Code.

Each legislature session, the Comptroller's office provides the Legislature with revenue and balance estimates as prescribed by Section 403.121, Government Code. In some cases, the Legislature appropriates more than the estimated biennial revenue for an account and the balance of that account is used to fund the appropriations. When the Legislature does not appropriate all of an account's revenue stream, or when revenue exceeds the estimate, a balance will accumulate in the account. The balances in General Revenue Dedicated accounts are available for certification of General Revenue appropriations according to the provisions of Section 403.095, Government Code.
